

Code of Conduct at SFHS Model United Nations Conference and Policy Contention 2023

Our intention is to create an atmosphere that fosters learning, professionalism, and environmental consciousness. All participants are expected to adhere to the following code of conduct:

1. Respect and Professionalism:

a. Treat all participants with respect, courtesy, and professionalism throughout the conference.

b. Maintain a positive and constructive attitude during committee sessions, social events, etc.

c. Strictly refrain from using derogatory language, engaging in personal attacks, or any form of discrimination or harassment.

2. Preparation and Participation:

a. Thoroughly research and prepare for your assigned roles, including knowledge of the topic, country/organisation, and rules of procedure.

b. Actively engage in committee debates, discussions, and negotiations, offering thoughtful contributions and ideas.

c. Adhere to speaking time limits and follow the established rules of procedure.

3. Punctuality and Attendance:

a. Arrive on time for all scheduled sessions, including committee sessions, social events, etc.

b. Inform your faculty advisor or head delegate in advance if you are unable to attend any part of the conference, who in turn must apprise the Secretariat of the same.

Kindly note: You are eligible for an award only if you have attended all the committee sessions.

4. Dress Code:

a. Dress professionally and appropriately throughout the conference, adhering to the dress code guidelines provided in the Conference Schedule.

5. Technology Usage:

a. Carry your own electronic devices.

b. Use electronic devices solely for conference-related purposes, such as research or accessing relevant conference materials.

c. Strictly refrain from engaging in activities unrelated to the conference during sessions.

d. The school is a WiFi-enabled zone.

6. Environmental Responsibility:

- a. Carry a personal water bottle to the conference venue.
- b. Utilise the provided RO water dispensers for refilling your water bottle during breaks.
- c. Carry your own stationery and other necessary resources.

d. Embrace our environmentally conscious approach by avoiding the use of disposable glasses or containers.

7. Confidentiality and Diplomacy:

a. Respect the confidentiality of sensitive information discussed during closed-door sessions.

b. Maintain diplomatic courtesy while representing your country/organisation and interacting with representatives of other countries/organisations.

c. Represent your country/organisation with dignity and cultural sensitivity.

d. Refrain from expressing personal opinions that contradict your assigned role.

8. Collaboration and Cooperation:

a. Foster a spirit of collaboration and cooperation among all participants, encouraging inclusive dialogue and consensus-building.

b. Strive to find common ground and promote solutions that benefit the international community as a whole.

9. Compliance with Rules and Regulations:

a. Follow the guidelines and rules set by the Secretariat and the organising team.

b. Abide by the rules of the school and conference venue regarding behaviour, safety, and security.

c. You are strictly prohibited from using, possessing, soliciting or distributing intoxicants, cigarettes, e-cigarettes, alcohol, or any other substance, at any time during the Conference.

10. Consequences of Misconduct:

a. Violation of the Code of Conduct may result in disciplinary actions, including but not limited to warnings, removal from committees, or disqualification from the conference.

Kindly note: The Secretariat, Organising Committee and/or School Authorities are not responsible for the delegates' belongings. Delegates need to be responsible for their possessions.
